#### 1. How do we collect information about you?

We collect information about you in cases when you apply for insurance.

Information that we receive about you:

- From Citadele Leasing SIA:
  - Name, surname, personal identification code;
  - Phone number, email address;
  - Place of residence;
  - Vehicle make and model, VIN (vehicle identification number) and technical specification data;
  - Information about another leasing object.
  - From our cooperation partners joint stock insurance companies:
  - An insurance offer containing your name, surname, personal identification number, residential address and the terms of the insurance offer.
- From you, if you independently contact us with a request to prepare an insurance offer:
  - Name, surname, personal identification code;
  - Phone number, email address;
  - Place of residence;
  - Vehicle make and model, VIN (vehicle identification number) and technical specification data;
  - Information about another insurance object.
- From you, if the insurance policy is terminated and you need to return the balance of the premium:
  - Bank account number.

## 2. Why do we process information about you?

We process information about potential and current customers for the following purposes:

#### 3. To whom do we disclose your information?

We have introduced various tools and services that facilitate our cooperation and make our communication faster. Therefore, we disclose:

- Your name, surname, personal identification code to vehicle and equipment registration authorities, for example, VAS "Ceļu satiksmes drošības direkcija" /Road Traffic Safety Directorate SJSC/ and VAS "Tehniskās uzraudzības aģentūra" /Technical Supervision Agency SJSC/;
- Your name, surname, personal identification code and other aforementioned information to companies, if you have confirmed that you want to receive an insurance offer for a vehicle or disclosure of the mentioned data to insurance companies listed in Section 5 of this Policy is required to comply with the terms of the Leasing Contract;
- Information about you found in the insurance documentation file to archiving service providers and providers of debt collection services;
- Your contact information to communications providers and IT service providers for administration of insurance services;
- Information about your requests and complaints as well as information about various types of incidents (e.g., incidents related to activities that do not comply with internal and external regulatory enactments, data protection violations), if any, to Citadele banka AS to ensure risk management on the Citadele Group level and improve the quality of service and customer service;
- If you have agreed to receive advertising, to Citadele group companies: Citadele banka AS, CBL Life AS, CBL Atklātais pensiju fonds AS, CBL Asset Management IPAS, Citadele Factoring SIA, Citadele Leasing SIA, address: Republikas laukums 2A, Riga, LV-1010;
- State supervisory/investigative bodies and other law enforcement bodies, government officials specified in regulatory enactments, external
  auditors/consultants.

If you do not pay insurance premiums in accordance with the terms of the insurance contract even having received our reminders, we will decide that it is necessary to hire experts to recover your debt. In this case, we will process your personal data to ensure our legitimate interest in recovering the debt. If we decide to transfer your debt to a debt collection company, we will provide them with your name, surname, all contact information, a copy of the insurance contract and any annexes thereto as well as information on all previous payments and other information that may facilitate debt recovery.

## 4. How do we process your information when sending you notices and offers?

We or any of the Citadele Group companies will prepare the following notifications and offers, incl. personalized offers, personal credit limit offers, and send them to you from time to time, if you have given your consent to the processing of your personal data on our website or unified consent form.

According to your consent, we will send you:

- up-to-date information on financial services provided by Citadele Group companies, for example, account opening, payment card processing; deposit services; lending services; leasing services; insurance services; financial instruments services, etc. services and related offers, incl. personalized offers within customer loyalty programs;
- other notifications related to opportunities to participate in competitions, lotteries, promotions and other customer-related events; congratulations on your birthday, name day and other holidays (for example, National Independence Day, Easter, Christmas, Ligo and other holidays); our comments on current events in the Latvian and world economy; opportunities to express our opinion about the services we provide and the quality of service by participating in customer surveys organized by us; social responsibility and support projects; our financial performance, awards, special events;
- up-to-date information on credit limits available to you personally (for example, payment card credit limits, consumer credit, leasing offer), which will be prepared by financial consultants of Citadele banka AS and/or Citadele Leasing SIA upon evaluating your financial possibilities.

Withdrawal of consent (s) will not affect the lawfulness of processing of your personal data prior to withdrawal of consent.

#### 5. How do we process your information when offering you insurance services?

For vehicle insurance or other types of insurance, we cooperate with several providers of insurance services - insurance joint stock companies, their branches. If we receive your application for the preparation of an insurance offer, we will transfer your personal data (see Section 2 of this Policy) to insurance joint stock companies, their branches in order to receive an offer for insurance of a vehicle or other insurance object and arrange insurance for a vehicle or other object.

For vehicle insurance, we cooperate with several insurance providers listed in the table below.

### 7. What are your rights?

We process your data, so you can find out what we do with it and how we process it. You may, upon written request, access, correct or delete your personal data, restrict processing, object to processing of such data and transfer them free of charge.
